# **Attention All Junior Smallbore Rifle Shooters!**

The NRA is pleased to announce that its annual **NRA Junior Smallbore Rifle Camp** will be held on **July 05 – 10**, **2015**, at **Petrarca Range**, **Camp Perry**, **Ohio**.

### CAMP PROGRAM AND OBJECTIVES:

All smallbore & air rifle camp students will receive expert coaching in the fundamental principles and techniques of **3- position** and **4-position** smallbore rifle shooting. Students will be provided a safe, enjoyable learning experience that will significantly contribute to improving their shooting skills.

# STUDENT ELIGIBILITY:

The smallbore rifle camp has been primarily designed for the intermediate shooter. And will be held using both smallbore and air rifles. Students must supply their own smallbore rifle. Students are encouraged to bring their own air rifle – but the CMP will lend sporter air rifles to campers who do not have one to bring.

All applicants are encouraged to apply as soon as possible.

**First admission** will be for junior shooters who have fired in a NRA Junior 3P or 4P Smallbore Sectional competition, then Junior's with 3P Precision Air Sectional scores. List location of sectional, type, date and score fired. (**attach a highlighted results copy**) USA 3P JORC scores will be considered. First admission is open until April 30<sup>th</sup>, 2015 (based on postmark) Starting May 1<sup>st</sup> admission will be first come, regardless of experience. You may submit as a first admission candidate if you anticipate shooting a smallbore sectional between March 1 and April 30<sup>th</sup>, 2015. Participation in that sectional will be required to keep a first admission status.

**Second Admission:** Juniors shooting 3P Sporter Air, Beginners, or shooters who have attended NRA Advance Camp will be admitted **on a first come basis if space is available** after May 1, 2015. Shooters need to be at least **12 years old.** Age Exceptions will be considered after May 1, 2015. Apply as soon as possible. If you are a second admission candidate, your application will remain on hold until after the First Admission deadline has passed on April 30, 2015. If space is available, you will be accepted on a first come basis determined by postmark. (i.e. A Second Admission candidate with a post mark of March 1<sup>th</sup> will be selected before any candidate with a postmark of May 1)

# ADULT SPONSORSHIP:

Students who have not reached their **18**<sup>th</sup> **Birthday** by July 1, 2015, must be accompanied to Camp Perry by an adult sponsor (age 21 or older). An adult may not sponsor more than **three** junior students.

# **REGISTRATION AND FEES:**

Registration forms and fees for camp will be accepted at NRA Headquarters on a first-come, first-served basis. For all mailed entries, the earliest postmarks will be used to determine order of acceptance. Registration fees cover all administrative costs and training materials. (The registration fees do not cover other costs such as travel and room and board.)

- Advanced Registration: The fee for advanced registration is \$225.00 per student, and must be received with registration forms by the NRA not later than June 01, 2015.
- Standard Registration: The fee for standard registration is \$250.00 per student.
   This fee will be charged for students whose registration materials are received after June 01, 2015 (postmarks will determine acceptance of all mailed materials), or for students who register directly at Camp Perry.
- In the case of cancellation by the camper, refunds will be issued less a 20% administrative fee.

All required entry forms for the Smallbore Rifle Camp are enclosed with this letter, and consist of:

- Registration Form (must include NRA Jr. Sectional scores)
- Health History Form (this form must be notarized)
- Special Power of Attorney Form (for campers with sponsor other than parent (this form <u>must</u> <u>be notarized</u> and retained by/with the campers sponsor so they may care for the camper.
- Required and Optional Equipment Form
- Lodging Information

Students should review all entry forms with their parents prior to submission.

The NRA will acknowledge all student entries in writing, and Camp Perry Reporting information will be sent to each student with the acknowledgement letter.

# OTHER COSTS:

Students are required to cover the cost of their room and board, plus all other incidental and personal expenses.

Cost of lodging in Camp Perry huts will be \$43.90 per night for the hut. Hut lodging arrangements must be handled directly with the Camp Perry Clubhouse Rental Office (See the enclosed *Lodging Information* materials for details).

## CANCELLATION OF CAMP:

The NRA reserves the right to cancel the smallbore rifle camp if a minimum of 50 students have not registered by June 01, 2015. Cancellation notifications will be mailed and emailed to each registrant if the camp is canceled.

# STAFF QUALIFICATIONS:

All instruction and coaching will be conducted by outstanding official **NRA Certified Coaches**, **including members of the NRA National Coach Development Staff**.

Camp Activities for 2015 will be divided between 50 & 100 yd. smallbore rifle shooting on Petrarca Range, Camp Perry, and 10 meter Air Rifle shooting on the CMP Gary Anderson Air Rifle Range, Camp Perry. All campers will spend time at both ranges and will practice and compete in both smallbore and air rifle. Camp direction is to give shooters the boost required to improve scores that may lead to collegiate shooting. Both Smallbore & International Standing Air Rifle are priorities but all campers will attempt some 3P air practice or matches as well.

#### SMALLBORE RIFLE CAMP LODGING INFORMATION

Available Lodging Types -

Huts: 4 single beds, \$43.90 plus tax per night.

Other lodging types may be available at Camp Perry, such as open bay barracks, modular housing, and/or cottages. Current rates apply.

Reservations for hutments or barracks may be made beginning on April 21<sup>nd</sup> through the 25<sup>th</sup>, 2015 by telephoning the Camp Perry Housing Office toll free number–1-888-889-7010. Be sure to get a confirmation number. Housing is assigned on a first-come, first-served basis. A deposit is required. Housing fees are to be paid on arrival at Camp Perry. Housing information is also available at *http://www.cplcc.com* 

No written requests will be accepted for lodging.

When calling to book your lodging:

- Know your arrival and departure dates.
- Names and addresses of your roommates, if any.
- Credit card (MC, VISA, or American Express), a non-refundable deposit will be required when making your reservation. The deposit fee will be processed and be charged to your credit card account <u>at the time of your call.</u> (Deposit payment is equal to the first night's rent on each rental unit reserved, and is a non-refundable payment.) Deposit payment may not be moved to cover the cost of other beds. Each confirmed room's first night's rent is based on the deposit applied to that room only, if the room is canceled at any time, this deposit is forfeited.
- You will be given a confirmation number at the time of your call. No confirmation letter will be sent.
   Please keep this number somewhere safe. You will need to have this number to make changes and at check-in.
- Check-in time for all reservations is from 2:00 p.m. until 10:00 p.m. on your arrival date. Reservations, which are not picked up by 10:00 p.m. on the arrival date, will be considered canceled, unless arrangements have been made with the Camp Perry Clubhouse Rental Office prior to the 10:00 p.m. cut off. Checkout must be accomplished no later than 10:00 a.m. on your departure day. Additional charges will be incurred for late check-outs and no show/failure to cancel reservations.
- Requestor must be 18 years of age or older to request reservations. Proof of age may be requested upon check-in.

- 10. Spotting Scope with Stand for use in Prone to Standing Positions (Recommend 20X min.; Higher Power or Variable Power Optional)

- 13. 16 Target Clips (binder clip No. 100 Large)
- 14. Standing Position Rifle Stand; Beginners can fabricate using medium to heavy duty camera tripod and soft covered wooden block attached at camera position, 3"X4"X1".

- 16. Cleaning Rod, Single piece, plastic coated recommended, with JAG.
- 17. 2-3 Bore-Brushes, .22 Cal. Rifle (other than for pistol)
- 18. Bore Cleaning Solvent, 4-6 ounce bottle (If glass bottle, should be wrapped with several layers of Masking Tape to help prevent breakage.)
- 19. 50-100 Bore Cleaning Patches
- 20. Tooth Brush for Rifle Cleaning
- 21. Q-Tips for Rifle Cleaning
- 22. Ammunition: 1000 rounds of standard velocity target ammunition (optional, but strongly recommended)

- 4. Rain Gear Rain Suit and 6' X 8' Light Weight Waterproof Material for use to cover shooting equipment. Poncho not recommended for use while shooting.
- 5. Stopwatch or Electronic Timer. A timer that will permit the count-down of hours and minutes is recommended.

<u>Acceptable Rifles</u> - The camp will accept any .22 caliber target type rifle that meets Rule 3.2 of the current NRA Smallbore Rifle Rules. Any Air Rifle that meets Rule 3.6 of current NRA International Rifle Rules. Any Air Rifle that meets National Standard Three-Position Air Rifles Rules 4.2 Sporter Air Rifle or 4.4 Precision Air Rifle.

NRA Smallbore Rifle Rule 3.2 ~ A rifle authorized for use in Smallbore Rifle Matches using cartridges commercially catalogued as the .22 Short, .22 Long or .22 Long Rifle cartridges. There are no restrictions on the barrel length or overall weight of the rifle and accessories. Any safe trigger is allowed. No portion of the rifle or any attachment to the rifle shall extend more than 3 inches beyond the rear of the shooter's shoulder. A butt plate conforming with NRA Rule 3.15 may be used. Around the body, or around the shoulder hooks are not permitted. The same rifle must be used throughout all stages of any one match (except aggregate) except in the case of a malfunction or disabled rifle when the competitor may change rifles with permission of the Chief Range Officer. In NRA Metric Position Course shooting, this rule will govern the conduct of the match and may not be waived by the Match Sponsor.
